

3. Three (03) sets of research publications must be provided in binded / perforated form, else the application form shall not be entertained, where applicable.
4. Foreign degrees holders must submit the equivalence certificate issued by HEC Pakistan.
5. All educational documents / testimonials shall be attested by HEC Pakistan before or on the cut-off date of advertisement.
6. By hand submission of application form in the University shall not be allowed for what-so-ever reasons.
