1. Each bidder must submit a Bid Security equal to 5% of the quoted bid amount in the form of a Pay Order in favor of DUET, Karachi. This must be enclosed in the sealed envelope along with the participation request and quoted price..
2. Auction Fee (Non-Refundable) Rs. 3000/- in shape of Pay Order in favour of DUET, Karachi.
3. Registration with FBR for Income Tax, NTN/GST & SRB
4. Active Taxpayer
5. Last 05 Years Annual Turnover 1.5 Million per year (Attach Certified Bank Statement or Bank Certificate or FBR Returns)
6. Undertaking on Stamp Paper that Bidders/Firms that have been blacklisted or are in litigation with any public sector university, private university, government department, semi-government organization, or other institution within the last 2 years shall not be eligible to participate in this bidding process. They must provide an undertaking on stamp paper to this effect.
7. An interested bidder can inspect the old bus at the main campus from the date of publication till 16-02-2026 (Time from 12:00 am till 03:00 pm) under the supervision of the Director Student & Security. **For visit / inspection an a request letter is mandatory on company's original letter head along with Original CNIC.**
8. The contract shall be awarded to the highest bidder, subject to the approval of the Worthy Vice Chancellor. The successful bidder must pay the full auctioned amount within three (03) days of approval. In addition to the bid amount, the bidder shall bear all applicable government taxes as per the prevailing rules. Bidder shall be responsible for all taxes.
9. The bid security of unsuccessful bidders shall be released upon confirmation of full payment by the successful bidder.
10. DUET Authority reserves the right to cancel all or any auction bid.
